Proposer / Seconder or Referees

Prospective members who are Proposed and Secondered may apply for membership at any time. The Proposer / Seconder must be a financial member of Indooroopilly Golf Club, of at least twelve months standing, over the age of 18 years and who knows the applicant personally.

Prospective members who are not Proposed/Secondered may apply during the periods that membership is open, in which case they must supply the names and details of two Referees.

On receipt of the application, nominations for Membership shall be displayed for 14 days on the Club's noticeboards, references checked and interviews undertaken where required. Applications shall be submitted to the Board for decision. Candidates shall, if elected by the Board, become Provisional Members of the category for which they have been nominated. Subject to the approval of Board, Provisional Members shall be transferred to Full Membership in their respective classes as and when vacancies occur, in accordance with the Club's Membership Policy.

Entrance Fees

The entrance fee is payable within one month of notice to the candidate of his/her election to Membership. If paying by instalments, the first instalment of the entrance fee is payable within one month of election. The following three instalments are payable on the anniversary of election for the next three years. Members choosing to pay by instalments are liable for the whole fee regardless of whether they resign from the Club prior to all of the instalments being paid.
