## GENERAL

### Eligibility for Competitions

No member has an entitlement to play in the competition fields until allocated a Golf Australia (GA) handicap and deemed conversant with the Rules of Golf.

### Handicap

To obtain a GA handicap, 3 x 18 hole stroke cards must be returned to the golf shop for both men and women.

### Single Sex Competitions

The club runs single sex competitions for members on the following days:

- **Women** – Monday, Tuesday, Wednesday, Thursday and Saturday
- **Men** – Tuesday, Wednesday, Thursday and Saturday

The times allocated for these single sex competitions are set by the Board and are subject to change without notice. Only members with a GA handicap and whose category and sex allows them to access these competitions are eligible to play.

### Social Play

Social play is only permitted during the times allocated on the time sheets for Social play. Social play is not permitted during, or as part of, any allocated male and female Competition tee-times, regardless of whether there may be unfilled tee slots within the Competition times.

All players wishing to book Social tee times may do so via the website or may contact the Golf Shop to make a booking prior to arriving at the course. All members **MUST** report to the Golf Shop prior to teeing off and all Social play shall be from the first tees only and subsequent holes played in their correct sequence.

### Member's Guest access

Guests may play a **maximum of six (6) times per year** in social or competition play. All invited competition guests must have a GA handicap.

### Intra Membership Transfers

No Membership Categories (Including Clubhouse) can be transferred between family or friends

### Playing Rights

Members in this category are entitled to full course access with the only restriction applicable being to single sex competitions as follows:

- **Men** – may play on all occasions except in the women’s competitions.
- **Women** – may play on all occasions except in the men’s competitions.

### Visitors

- Social tee times – three (3) guests per member
- Competition tee times – one (1) guest per member\*
- Member’s guest green fee applicable

## 7 DAY | FULL MEMBER TEMPORARY

**This Playing Category has been Grandfathered. No new applicants or transfers into this category will be accepted.**

### Playing Rights

Temporary membership is ideal for business executives who have been transferred to the Brisbane area for a short period of time and would enjoy being a member of a premium golf club without having to pay an Entrance Fee. A temporary member will have full member playing rights, with a maximum term of three years. After three years, temporary members will be invited to apply for ongoing membership at the club. At this time an entrance fee would apply.

The golf fees payable would include the full member annual subscription plus a 25% loading in lieu of an entrance fee plus golf levies.

Members in this category are entitled to full course access with the only restriction applicable being to single sex competitions as follows:

- **Men** – may play on all occasions except in the women’s competitions.
- **Women** – may play on all occasions except in the men’s competitions

### Visitors

- Social tee times – three (3) guests per member
- Competition tee times – one (1) guest per member
- Member’s guest green fee applicable

### Playing Rights

Members in this category are entitled to golf course access in accordance with the following conditions:

- **Men** - may play on all occasions except in the women’s competitions and Saturdays.
- **Women** - may play on all occasions except in the men’s competitions and Saturdays.
- **Weekend women\*** - may play on all occasions except in the men’s competitions and on Tuesday in the women’s competition (however can participate in Women’s competitions on Tuesday up to six (6) times per year on payment of the guest green fee in accordance with the provision noted below\*.
- **Restricted weekend women** category has been Grandfathered to new applications. If women wish to play on a Saturday they need to join as a Full Member.

- Competition tee times - one (1) guest per member
- Member’s guest green fee applicable

## COUNTRY MEMBER

This category is available to members whose place of residence is more than **80kms** from the club (or as the Board reasonably considers being sufficient in the case of a particular application).

### Playing Rights

Full course access is restricted to **22 rounds of social or competition golf per subscription year\*** and with the additional restriction to single sex competitions as follows:

- Men – may play on all occasions except in the women’s competitions.
- Women – may play on all occasions except in the men’s competitions.

Where the member changed to the country category during the subscription year, the number of rounds is allocated on a pro rata basis from the date of change

Following **twenty-two (22) rounds**, or the relevant pro-rata rounds, a Country member may play up to six (6) times per year on payment of the out of category fee – book with the golf shop (online bookings are not available).

**Category Requirement:**

- Family Anchor
- Family: Brothers, sisters, wives, husband, parents, sons, daughters, de facto, step parents, step children, step brothers, step sisters, grandchildren, grandparents
- The Anchor must remain as a Full or Restricted Member

**Playing Rights**

- Social course access only on every day except Saturday, outside competition times and other tee closures.

**Visitors**

- One (1) guest per member.
- Member’s guest green fee applicable.

**Members may play outside the playing rights of their category up to six (6) times per year on payment of the guest green fee – book with the golf shop (online bookings are not available).**

## LIFESTYLE MEMBER

- Social course access only on every day except Saturday, outside competition times and other tee closures.

### Visitors

- One (1) guest per member.
- Member's guest green fee applicable.

**Members may play outside the playing rights of their category up to six (6) times per year on payment of the guest green fee – book with the golf shop (online bookings are not available).**

## LEAVE OF ABSENCE MEMBER

Leave of Absence is available for a **minimum of six (6) months** to any member who the Board considers has a satisfactory reason to take leave at the time of application.

Members in this category have no playing privileges other than those outlined below, however they continue to receive regular club communications and may freely enjoy the clubhouse and practice facilities.

### Playing Rights

May play on any course, in competition or socially, up to **six (6) times** in a subscription year\*, paying the member's guest green fee:

Competition Play - members on leave may play as the guest of a member in competition, on payment of the member's guest green fee. Members on Leave, playing as the guest of a member in competition may not invite guests.

Social Play - members on leave may play social golf on payment of the member's guest green fee. They may invite up to three (3) guests to play with them socially, paying the members' guest green fee for their guests.

After six (6) games course access and charges revert to those of a public player (non-member).

### Temporary Playing Rights

- Leave of Absence members can purchase playing rights in blocks of 30 days for the playing category they have transferred from, for up to a total of 90 days in any one year.
- The member will pay the pro rata amount of the annual subscription of their past playing category

## CLUBHOUSE MEMBER

This category is open to all persons who wish to enjoy the social facilities of the club, excludes all golf playing rights except that available to public members, and excludes any additional sporting facilities that may become available in the future.

Clubhouse members may invite visitors to join them for a drink and/or meal in the Poinciana Bar.

**If a member transfers to clubhouse they must acknowledge that there is no right to transfer back to a playing category/member.**

### **Playing Rights**

- Membership cannot be transferred to Family or Friends

## LIFE MEMBER

A member may be nominated by another member to be considered for life membership of the club. The Board will assess the nomination against approved criteria for life membership – period of membership, service to the club, service to golfing organisations, golfing achievement, patronage and acceptability to membership.

### Playing Rights (as per Full Member)

Members in this category are entitled to full course access with the only restriction applicable being to single sex competitions as follows:

- Men – may play on all occasions except in the women’s competitions.
- Women – may play on all occasions except in the men’s competitions.

### Visitors

- Social tee times – three (3) guests per member
- Competition tee times – one (1) guest per member
- Member’s guest green fee applicable

## HONORARY MEMBER

A member or iconic person who does not meet the life membership criteria may under special circumstances be offered honorary membership of the club by the Board.

An iconic person is someone that people (the public) look up to/admire for the contributions they have made in their field. The person also needs to be someone that the Board believes will be a good fit and ambassador for the club.

If an iconic person is invited by the Board to consider honorary membership, their partner is also invited to consider honorary membership.

An iconic membership will be proposed for a five or ten year period and subject to Board renewal following the proposed period.

### Playing Rights (as per Full Member)

Members in this category are entitled to full course access with the only restriction applicable being to single sex competitions as follows:

- Men – may play on all occasions except in the women’s competitions.
- Women – may play on all occasions except in the men’s competitions.

- Competition tee times – one (1) guest per member
- Member’s guest green fee applicable

## TOURING PRO (AUSTRALIA OR OVERSEAS)

Persons eligible for this category must be prior members of Indooroopilly Golf Club for a minimum of 6 months and show evidence of being a touring professional golfer – either touring in Australia or overseas.

Persons in this category can apply to be a Full or Restricted member. Touring Pros have the same playing rights as other members in the Full and Restricted category.

## GOLF AMBASSADOR

The Board will consider recommendations from the Club Captain and Membership Committee for talented golfers, as well as direct approaches from golfers, to join the club's golf ambassador program. Applications will be assessed under the golf ambassador framework.

Acceptance as a golf ambassador member is for a period of **12 months**. An annual review will determine ongoing suitability as a golf ambassador member.

### Playing Rights (as per Full Member)

Members in this category are entitled to full course access with the only restriction applicable being to single sex competitions as follows:

- Men – may play on all occasions except in the women's competitions.
- Women – may play on all occasions except in the men's competitions.

### Visitors

- Social tee times – three (3) guests per member
- Competition tee times – one (1) guest per member
- Member's guest green fee applicable

### Note:

Existing Life, Full, Restricted or Country Members who achieve Golf Ambassador status retain their Membership category rights according to section 9.1 of the Club's Constitution.
